Please upload at least one writing sample.

5. English Language Proficiency Certificates (IELTS, TOEFL or equivalent)

All applicants whose native language is not English and who have not completed their entire undergraduate education in English must submit valid scores from internationally recognised assessments of English language proficiency.

6. GMAT, GRE, GRE Mathematics Subject Test Certificates (optional)*

These examinations are not mandatory; however, taking them and achieving high scores may enhance your chances of a successful application.

7. Recommendation Letters

You may submit one or more letters of recommendation, with at least one from someone familiar with your academic work. Please provide your referees with HSE's guidelines for letters of recommendation.

EVALUATION CRITERIA

The maximum grade attainable is 100. Students' portfolios are assessed against the following criteria: relevant academic background and performance, the quality of research papers, certified personal achievements (such as victories in academic competitions), and references from an academic supervisor or esteemed experts.

1. Academic background and academic performance (up to 50 points)

Grades on relevant (economic and <u>mathematical</u>) courses are taken into account, with additional bonuses awarded for honours degrees and participation in the <u>ICEF Summer Bridge School</u>. International ranking of the candidate's university is also considered and graded.

2. Research papers and publications (up to 30 points)

Points are awarded based on expert evaluations. Experts allocate points for:

- The scientific novelty of the paper
- Compliance with the requirements of international peer-reviewed journals
- The methodology applied
- The theoretical model (for theoretical research)
- The choice of data and econometric techniques employed (for empirical research)

3. Personal achievements of the candidate in relevant fields of economics, finance, and mathematics (up to 15 points)

Points are awarded based on expert assessments. Experts consider:

- University contests
- Awards, winners' diplomas, and certificates of achievement
- Study or research grants
- Other academic competitions
